- These revised rates of interest on term deposits will be applicable on fresh or on renewal of existing deposit on maturity on or after **28.07.2025**.
- 1% additional rate of interest shall be allowed on deposits, in the name of members or retired members of our bank's staff either singly and jointly with any other member or members of his/her family subject to the declaration that the money belongs to him/them only.
- Extra 0.50% & 0.75% interest rate shall be allowed to the Senior Citizens and Super Senior Citizens respectively on term deposit.
- No interest shall be paid if the deposit remains with the Bank below 14 days on term-deposits in case of premature withdrawal.
- The other term & conditions with respect to premature payment by staff as well as others shall remain unchanged as per letter No. Bkg./Misc./ 2010-11/16982 dated 24.01.2011.
- No penalty shall be charged from the customer on the amount withdrawn prematurely but reinvested in the same branch for the period longer than the remaining period of original contract.
- In case of staff Senior Citizen and staff Super Senior Citizens the benefit should not exceed 1.50%.
